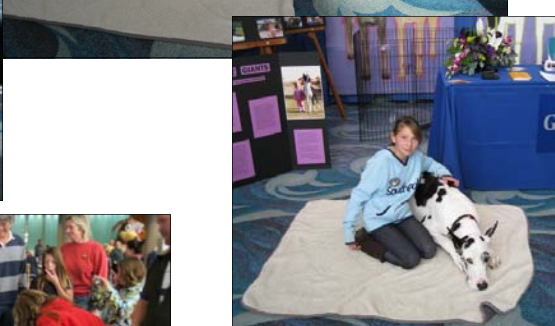
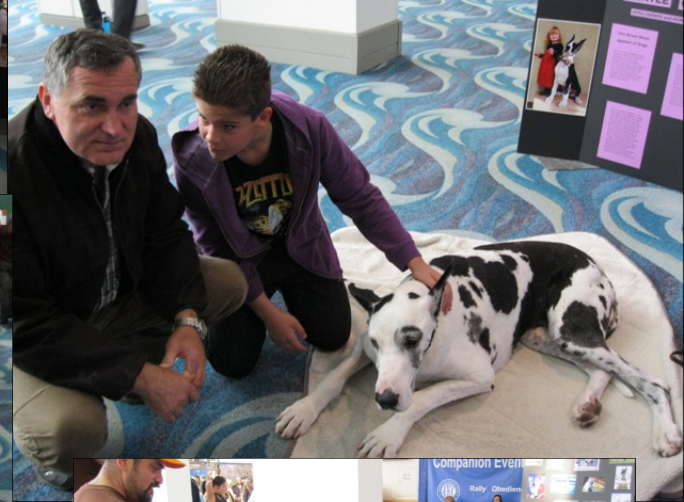

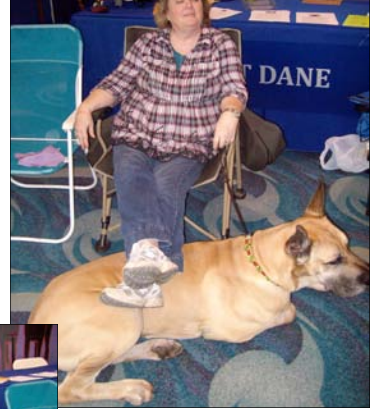

# HOME-MADE DOGGIE BISCUITS - THE PEANUT BUTTER VARIETY

Compliments of Carol Hickman, a GDCC Supporter!

Time: Takes about 30 Minutes From Start to Finish

Preheat Oven To 350 Degrees.

## Ingredients:

1 1/2 cups wheat flour  
1/2 all-purpose flour  
1 TBSP baking powder

Put in a bowl and set aside.

Mix together in a separate bowl:

1 cup Peanut Butter (smooth or chunky)  
3/4 cup milk  
Mix until smooth

Slowly add peanut mixture to flour mixture. Knead dough for several minutes. Place dough on a floured surface and roll out. \*\* Then cut with cookie cutters. Place in oven on cookie sheet wrapped in aluminum foil for 15 minutes.

**And you're done! And all the puppies in the neighborhood will love you eternally!**

\*\* Tips!

1. Put wax paper over the dough before rolling; eliminates cleaning the rolling pin afterwards.
2. Pizza cutters work great on cutting the dough.
3. Biscuits will be bake in 15 minutes if convection is on; much longer if it's not.
4. The biscuits will last for at least a month in a container on the counter.
5. A small jar of peanut butter works great for doubling the recipe.



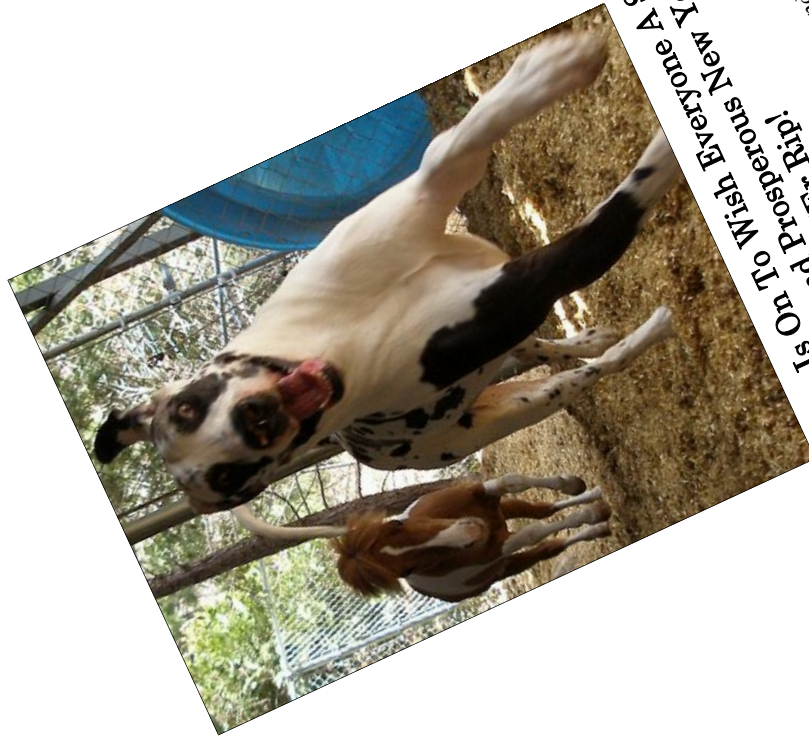
