




*Treasurer's Report* – Linda reported that the bank balance for September was \$8,072.92. She has received \$740.00 in dues, \$420 via checks and \$320 via PayPal. The balance at the end of October was \$8,812.94. Dues can be paid via PayPal. If you are having issues paying, contact Linda for assistance.

#### COMMITTEE REPORTS

*Rescue* – Susie asked for and received statistics for rescue numbers from One Dane at a Time: they have taken in 81 dogs this year, including 54 intact, and have placed 74 dogs so far. There were no statistics reported to Susie by Community Canine or Indian Danes.

*Bulletin* – Everything going well, nothing to report. Mindy will send out notifications for the upcoming bulletin deadlines.

*Website* – Mindy reported that updates have been made.

*Membership* – No new activity to report.

# CLOSED ZOOM MEETING MINUTES CONTINUES

*Holiday Party* – Linda requested for the Alta Vita Country Club in Placentia to host our holiday awards ceremony in 2021. They agreed to apply the deposit from the 2020 date to the 2021 date as there is no minimum amount needed for the party. The date for the holiday awards party will be December 11, 2021. There will be a fixed menu, no buffet, due to the current guidelines set for the pandemic. The contract has already been signed and sent back to the country club.

*Awards for Holiday Awards Party* – Gary Romerosa reported there had been one submission so far, and emails have gone out regarding the available awards and supporting documents needed. The deadline for submission is November 16.

## Old Business

Joy reported that no one has stepped up to volunteer for taking and renovating the trophy pieces she has. Maren suggested that we see what expenses are available to assemble them next year.

## New Business

*2023 National Specialty* –

*Voting* – Jim brought up voting for the 2023 National Specialty site approval, then Cathy and Joy (as the club delegates) will take that decision to the Western Division. Cathy detailed the amenities of the site in Santa Fe, NM. A concern brought up was that the casino on the site would draw people away from the auction and potentially damage National profits. They relayed that Kathy Munyan did not see the casino as an issue concerning the National.

*Positions Open* – The Western Division is still searching for a secretary, and they have found a Division Chair, Andy Barbee.

The decision to approve the site found for the 2023 National for the Western Division was motioned and carried fully. *Division Representatives* - Joy and Cathy both brought up that they had been the club representatives to the Western Division for a while and would like to pass on their positions to other members. The two representatives have to attend Division meetings held at specialties and the National of the preceding year.

*Mal and Virginia Helman* – Notice was sent out of the passing of two club members, Mal and Virginia Helman, via email announcement. The club has up to \$200 to spend without club approval. It was decided that we will wait for the obituary to be released before expenditures are made. Melanie will send flowers and a card to their daughter Michelle.

Ballots needing to be confidential, which could pose an issue virtually, but we will figure out how to vote confidentially.

*Specialty Chairperson* – A new chairperson is needed, so a separate announcement will be posted in the upcoming bulletin asking for potential chairpersons.

*Bylaws* – Zoom meetings fitting into the club bylaws were brought into question. It was suggested that if the meetings mentioned virtual meetings occurring (or not), then that would suffice – and if the bylaws make no mention of virtual meetings, then we are free to proceed. It was posited that we send a message to the AKC asking if we should modify our bylaws to include virtual settings. Melanie will call AKC and clarify, but the GDCA did not have to amend their bylaws, and the club should follow the parent club's lead.

The meeting was called to order by the President at 5:35pm. The following guests were present via video – Sharon Johns, Paul and Tracy Johnson, and Sam McLeod. Board members Brianne Rock and Jessica Gibbs were absent.

President Jim Howey dedicated this meeting in memory of Mal and Virginia Helman, inviting everyone present to share their memories of Mal and Virginia.

### OFFICER REPORTS

*Recording Secretary's Report* – The minutes from the previous two meetings were accepted as read, with the board minutes accepted with one correction (Eleanor Powell was not present at the second meeting).

*Corresponding Secretary's Report* –

#### **Incoming Correspondence:**

1. Denise Matulich stated she was forwarding approval for waiver of our GDCA 2021 annual dues to Kathy Munyan.
2. AKC Notification: Clubs licensed to hold AKC conformation events cannot transfer the club's name to a third-party service provider for the purpose of managing an event.
3. AKC Notification: Due to Covid-19 the AKC will continue to roll forward event application fees for 2021 events upon notification from the club that the event must be canceled. At that time the club should provide a future date to set the event.
4. AKC Notification: Multiple changes to event policies; more opportunities for competition on same day and site, change in indoor/outdoor location of judging, distance clubs can travel outside of their territory for conformation competition; waiver of policy restricting Judges from being assigned the same breed, group or BIS at events held within 30 days and 200 miles. More policy changes are available on the AKC web site.
5. Notification of the passing of confirmation Judge Pam Winter.
6. Confirmation from Kathy Munyan that the approval of the waiver for our 2021 annual dues to the Great Dane Club of American has been received.

#### **Outgoing Correspondence:**

1. Sympathy card and flowers sent to Mal and Virginia Helman's daughter.
2. Email was sent to Kathy Munyan requesting confirmation that approval of the waiver for our 2021 GDCA annual dues was received.
3. Letter of intent to change bylaws to include meetings by teleconference, videoconference or any other electronic means sent to AKC.

#### **Pending Correspondence:**

*Treasurer's Report* – Linda reported the October bank balance at \$8,812.94. After the \$287.52 in dues paid (\$152.50 via checks, \$135.00 via PayPal) and a disbursement of \$75.37 (Helman's remembrance), the receipts over disbursement was \$212.15, leaving the bank balance for the end of November at \$9,025.09. Linda has also sent out 17 second requests for dues.

# OPEN ZOOM MEETING MINUTES CONTINUES

## Committee –

*Rescue* – Susie reached out to the Southern California Dane rescues for their year-to-date statistics and reminded them they are offered a one-page ad in the bulletin. Indian Dane responded that he is canceling his membership as of January 2021 but would provide advice and assistance if needed. She had no response from Community Canine. Susie only received year-to-date numbers from One Dane at a Time, who reported 93 Danes taken in (63 intact) and 74 Danes placed.

*Specialty* – Jim reported that the Mission Circuit is still on for May and will be held either inside with 25% capacity or outside – Dick had been in contact for this Mission Circuit information with Loran Morgan. Melanie reminded us that we have judges with signed contracts for our 2021 specialties. Melanie questioned who she should contact for our specialty at the Mission Circuit since Arlene Davis stepped down from her position, and it was decided that Mike Rodriguez would get her Tony Vazquez's contact information. **As for finding a new show secretary**, it was proposed that we go to Bradshaw since Lea is no longer in state. Another issue brought up was that we **need a 2021 specialty chair**. Bruce agreed to search for options regarding our new show secretary.

*Puppy match* – The puppy match is scheduled for April 10, 2021, the Saturday following Easter. Linda will check with the RV park that has hosted our matches previously, but a second option is Lorrie Burnham hosting the match at her home in the High Desert.

*Bulletin* – Maggie reported that the deadline for submissions to the bulletin is December 14. It was explained that the position of GDCC Representative is no longer needed to be advertised in the bulletin as the positions are filled. Cathy is remaining in her position and Joy is being replaced in her position by Maren.

*Website* – Jerry reported that the website was up to date as of October 1.

*Membership* – Tori reported contact with Manuel Arevalo about joining the club – he expressed interest in attending meetings and meeting club members. She sent him information on the club and the requirements and application for membership. Melanie is in charge sending the club roster to the GDCA, including Joy's updated phone number.

*Pet Expo* – Jim reported that the Pet Expo is set to take place in April, but that is still up in the air.

*Holiday party* – The holiday awards party will be held on Saturday, December 11, 2021. Alta Vista Country Club agreed to move our deposit from the 2020 gathering to our 2021 gathering.

*Picnic* – The club picnic will take place in June. We will take pandemic restrictions into consideration and wait to fully decide on time and place closer to June.


